Don't worry if you have no experience of working within a corporate environment. The main requirement for this role is that you are willing to engage enthusiastically and have a real passion for making **Loddon Homes** and **Berry Brook Homes** the best landlords we can be for all our residents.

## About us

Loddon Homes and Berry Brook Homes (known as the Local Housing Companies) are part of a group of companies that are wholly owned by Wokingham Borough Council (WBC). We are modern providers of social and affordable housing in Wokingham.

The Local Housing Companies generate an income for the Council which is invested back into communities and services throughout the Borough. We provide high quality housing for local people, built by partners that share our vision and values, and everything we do is aimed at delivering first class services for our residents.

# Our values

Our values form a central part of our culture and how we work with residents, employees, partners and stakeholders. All members of our team, whether Non-Executive Directors (NEDs), staff or volunteers are expected to behave in ways that are consistent with our values.

#### **Board roles & responsibilities**

Our Boards are responsible for making sure we're successful by setting and monitoring our strategic direction, by providing oversight, support and constructive challenge to our management, and by ensuring our compliance with all legal and regulatory obligations.

Our Boards are made up of independent Non-Executive Directors (NEDs), who are appointed based on their knowledge and experience within the social housing industry; then there are three Council representatives from Wokingham Borough Council which include the Chair of each Board; our Managing Director; and **one resident NED**.

Our new resident NED will need to develop an understanding of how housing associations work so they can effectively contribute to Board discussions and help the Boards to set the vision and strategy of the Local Housing Companies. Training and support will be provided where needed to empower the successful candidate to fully contribute to the work of the Board.

**Board meetings take place bi-monthly during office hours** and usually last about two hours and are held at the WBC Council offices in Wokingham.



### The role of the **Resident Non-Executive Director**

Resident engagement plays a vital role in meeting our aims to increase resident satisfaction, and to provide high quality homes and housing services. The role of the **resident Non-Executive Director (NED)** is to make sure the voices of our residents inform how we shape our Companies.

We want to be certain that our residents' views and opinions are heard right at the top; that's why we have a resident sitting on our Boards. Resident Board members help us to see where and how we can improve our services; they participate in Board meetings so that they can influence the work we do, provide challenge and different perspectives to management, as well as many other unique functions and events.







#### There are many qualities needed in a housing association Board member.


